1 – GENERAL INFORMATION

2 – COMPOSITION

INCI list of ingredients: the complete list of ingredients is written on the package of the individual products as required by the Regulation (EC) No 1223/2009.

3 – HAZARD IDENTIFICATION

Application mode and warnings to be stated by Dir.: **WRITTEN ON THE PRODUCTS**

Whenever used according to the producer's instructions, the product is secure for man and the environment.

Follow the instructions written on the package. Keep out of the reach of children. The contact of the non-diluted product with the eyes can cause a moderate eye irritation. If the product gets in contact with the eyes, rinse immediately and abundantly with water. The ingestion can cause a slight irritation of the gastrointestinal tract. Do not apply on scalp that is harmed, irritated or suffering from pathologies.

Protect from sunrays and do not expose to higher temperatures than 50°C. Do not pierce nor burn, even after use. Do not spray over a flame or a white-hot object. Keep away from any source of combustion. Do not smoke. Keep out of the reach of children. Extremely inflammable.

- Carefully follow the instructions written on the package.
- Avoid any type of use that is not included in the instructions.
- Avoid spraying in the eyes or on irritated skin and any intentional inhalation.
- Spray for very short time intervals and adequately ventilate after use.

- Use and keep far from any sources of combustion and electrical appliances.
- Throw only empty bottles into the litter bin.
- Keep the product away from the reach of children.

4 – FIRST-AID MEASURES

Eye contact: irritating when in contact with the eyes; take off the contact lenses, if any, accurately and abundantly rinse with water; in case of persistent irritation, consult a physician.

Skin contact: in case of irritation, rinse well with water and consult a physician.

Inhalation: in case of large inhalation it can be irritating for the first respiratory tracts; take the individual out in the open air in case the environment is not sufficiently ventilated or is particularly saturated with steam. In case of persistent symptoms of irritation in the first respiratory tracts, consult a physician.

5 – FIREFIGHTING MEASURES

Flammability: inflammable. Possible risk of explosion in case of fire.

Type of fire-extinguishers: use dry chemical and CO₂ extinguishers for small fires and nebulized water or foam for large fires; cool containers with water.

Special protective equipment: use gloves, goggles, gas mask, etc.

6 – ACCIDENTAL RELEASE MEASURES

In case of massive spilling, please alert the Fire Department.

Gather the leaked product with rags, put it in containers that are fit for the type of disposal required by rules and regulations. Wash the contaminated areas with a great deal of water. Never use the product after it has leaked out.

7 – HANDLING AND STORAGE

In case the employer identifies risks that are not avoidable through other means, he must make appropriate Individual Protection Devices (IPD) available to the workers. The use of IPD supplied by the employer is compulsory.

In the specific case:

- Use work tools that have been accurately cleansed;
- Avoid nickel-plated tools;
- Avoid using costume jewelry;
- Wear a dust mask and appropriate goggles and gloves.
- Keep out of reach of children

Optimal storing conditions:

- Keep in dry and well-ventilated areas, at a temperature not lower than 5° C and not higher than 30° C, away from fire, sources of heat, or electric devices in function.

- Keep the containers in a vertical and secure position, avoiding the possibility of falls and/or collisions.

8 – EXPOSURE CONTROL/PERSONAL PROTECTION

Wear disposable gloves.

The continuous exposure for professional reasons to detergent agents (soap, shampoo, liquid detergents), can cause an impoverishment of the hydrolipidic mantle and of the horny layer that make up the natural barrier of the skin. The impoverishment of this barrier can be the cause of injuries to the skin, which thus results in being more exposed to external agents. In such conditions, the handling of other products, which are normally used during the professional activity, without the due precautions, can be the cause of intolerances which may in time develop into more serious forms.

10 – STABILITY AND REACTIVITY

Stable product under normal conditions of use.

11 – TOXICOLOGICAL INFORMATION

The product cannot be considered toxic under the normal and predictable conditions of use.

12 – ECOLOGICAL INFORMATION

The work environment must be adequately ventilated, eventually through mechanical change of air. The areas in which emissions of vapors, gasses, dust, or the spilling of substances may occur must be separated and fitted with localized extractor units or collection systems.

13 - DISPOSAL CONSIDERATIONS

The disposal of cosmetic products shall be in accordance with local regulations.

15 – REGULATORY INFORMATION

The finished cosmetic products are manufactured and marketed as required by the Regulation (EC) No 1223/2009 and its further modifications.
